At The Accident Scene

- Stay safe from traffic, fire, debris and other risks.
- Remain calm. Check for injuries to yourself or others.
- Call 911 to alert authorities. (Even if it does not appear to be a serious accident). Ask for an ambulance if needed.
- If you are safe and calm, use this guide to exchange the following information with any other drivers involved in the crash:

> Names

- > Addresses
- > Driver's license numbers
- > Make and model of vehicles
- > Vehicle registration



> Vehicle insurance



- Get names, addresses and phone numbers of all witnesses (act before they leave the scene).
- Obscuss the car accident only with the police.
- Obtain the name and agency of the responding law enforcement officer and crash report number.
- Do not leave the scene of the accident until the police V have finished their investigation.
- Take photos, unless it will put you or others at risk.



MAKE SURE TO GET THESE PHOTOS OF YOUR VEHICLE (AND OTHER VEHICLES IF POSSIBLE)

> All four corners

> License plates

> Rear

- > Driver's side
- > Passenger's side
- > Front

- - Report your accident to your insurance company or agent. Do not provide a recorded statement to an insurance company without first consulting an attorney.
 - Call or consult an attorney (and bring to your initial consultation as much documentation as possible about your accident and injuries).
 - Obtain a rental vehicle and arrange for repairs, if necessary.
 - Do not get your car repaired or replaced until you have photos of the damage.
 - O not throw away or lose evidence that may document your accident and injuries.

IF POSSIBLE, YOU SHOULD ALSO GET PHOTOS OF:

- > Street signs, traffic > Any nearby damaged controls, crosswalks property > Skid marks or brake > Conditions (weather, marks traffic, and/or road
- > Scattered debris
- > Landmarks (street signs or address markers
- Call a towing company to removed your car, if necessarv.
- Seek appropriate medical treatment, including possible referral to a specialist.
